This addendum forms a part of the Contract Documents and modifies the original Bidding Documents dated February 2024 and consists of page AD2-1 and attachments. The following changes, additions and/or deletions shall be made to the following documents; all other conditions shall remain the same.

ITEM NO. I – CONTRACT DOCUMENTS

If awarded the Contract, Bidder agrees to complete the proposed Work within **three hundred sixty five (365)** days after the date of commencement specified in the Notice to Proceed.

The University will pay the daily rate of compensation only for the actual number of days of Compensable Delay, as defined in the General Conditions; the actual number of days of compensable delay may be greater or lesser than the "multiplier" shown above.
