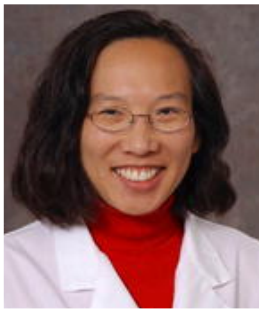


Su-Ting Li, M.D., M.P.H.

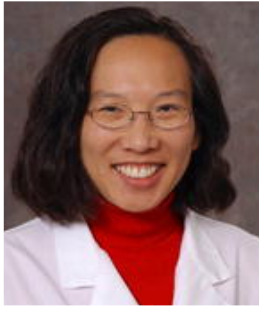
