Therefore, as an endocrinologist I may be asked to help evaluate and manage a specific endocrine problem, but I must always look at the specific problem in the context of the whole person. And that is my favorite part of being an endocrinologist.

I believe in caring for people, not just diseases. And I believe that each person has been created in such a way that they are very much like everyone else, yet also completely unique in many ways.

I always try to listen carefully and perform a thorough physical examination. I then evaluate and help manage your condition based on the most current, scientifically-based evidence available, and then individualize the plan of care to meet your specific needs.

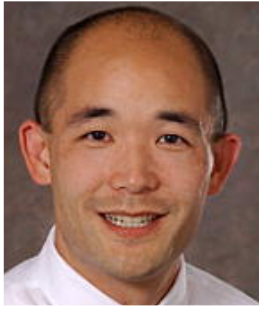
