His research addresses family violence, including treatment approaches for physically abusive families, sexually abused children, and survivors of childhood sexual abuse; and psychodiagnostic issues related to child mistreatment. He is also Director of the PCIT Training Center-a program whose mission is to disseminate parent-child interaction therapy to community mental health treatment programs around the world.
