Space: CHPR staff worked mostly remotely during FY 21/22 and continued to

be very productive. CHPR's lease with the Grange building ended June 30, 2021. During the Summer and Fall, CHPR staff, including former Institute for Population Health Improvement (IPHI) staff at The Cannery

building, relocated to the new university-owned space at 4900 Broadway, Sacramento, CA. As part of the complex move that took place during multiple stages, all logistical matters were successfully executed. This included ensuring workstations were properly set up, ensuring the telecom and computing needs of staff were met, and

coordinating with Reprographics to deliver and set up new

copier/scanner devices in two suites. While the assigned space in the Broadway building is a much smaller footprint than CHPR occupied in the Grange building, CHPR has been able to effectively utilize the

space due to staff having the ability to telework.

Significant Equipment/Instrumentation:

CHPR continues to use high-performance computers to support statistical analysis of large datasets (e.g., Department of Health Care Access and Information Healthcare Cost and Utilization Project databases, Medicare Provider Utilization and Payment Data, etc.). CHPR utilized six virtual servers from UCD Health IT this fiscal year to aid with analyzing large datasets while not tying up CHPR's existing computing resources. With dataset sizes continuing to expand, CHPR's computing capacity needs have also expanded. CHPR continues to partner with UCD Health to identify the best solutions to this challenge (e.g., utilizing the new Advanced Computing Environment [ACE]/HC2 and purchasing servers to be housed at the Data Center).

Mission Statement

The mission of the Center for Healthcare Policy and Research is to facilitate research, promote education, and inform policy about health and healthcare.

The goal of CHPR is to improve the health of the public by contributing new knowledge about healthcare access, quality, costs, and outcomes.

The objectives of CHPR are to develop, support, and conduct mission-related interdisciplinary and collaborative research projects; to support the education and career development of scholars interested in health services and health policy research; and to assist healthcare policy formulation and improve health services delivery through the synthesis, interpretation and dissemination of research findings.

We strive to achieve our goal and objectives through interdisciplinary, collaborative research, teaching and mentoring, research synthesis, and policy analysis.

To complement CHPR's mission statement and as a result of foundational planning with Raj Kapur, CHPR staff and faculty created the following "Why" statement: "To enhance the health and wellbeing of all individuals and communities by enabling research, developing researchers, and informing policy and practice."

Research Highlights

Research highlights of CHPR faculty, fellows and staff

During fiscal year 2021-2022, CHPR received funded awards, including grants to support work in substance use research, improve measures of healthcare quality, and inform health-related policy through both new research and rapid and systematic literature reviews. This includes a new 5-year grant funded by CDPH for The Healthy Living Clinic Initiative (HLCI) project.

Federal and federal-flowthrough funding was received, including from American Institutes for Research in the Behavioral Sciences (aka "AIR"; formerly known as IMPAQ International) for the "Patient Safety Measures" project, AHRQ for a project titled "Patient Safety Network" (aka "PSNET"), Mathematica for the "Hospital-Level Quality Indicators (QI's) Analysis and Support" project, AHRQ for the "Watchful Waiting" project, and HRSA for the "Prenatal Counseling for Postpartum Health—A Randomized Trial" project (aka "Healthy Moms" study).

CHPR received formal approval this year from UC Davis and the UC system of renewal of CHPR's status as an Organized Research Unit (ORU) for another 5 years, ensuring that the Center can build upon its successes achieved over the previous 28 years.

In FY 2021-2022, there were 11 CHPR-affiliated academic personnel with active grant funding administered through CHPR. The following sections briefly describe highlights achieved by CHPR-affiliated researchers in each of **CHPR's three primary research programs** during FY 2021-2022.

During FY 2021-2022, CHPR submitted 25 proposals for faculty affiliates. CHPR also submitted proposals for two pilot awards issued by the Behavioral Health Center of Excellence (BHCOE), one of which was funded.

Evidence to Inform Clinical Care and Health Policy

The goal of CHPR's work in evidence synthesis and policy analysis is to support the alignment of clinical practice, health policy, and healthcare reimbursement with science-based evidence and assessed value. To that end CHPR faculty conduct research and analyses designed to have relevance to clinical practice, specific healthcare policies, and healthcare costs. CHPR teams also conduct rapid evidence reviews as part of the California Health Benefits Review Program (CHBRP), which provides analyses to the California Legislature on the medical effectiveness, cost, utilization, and public health impacts of introduced health insurance legislation within a 60-day turn-around time to meet the Legislature's policy committee calendar; contributions to this program by CHPR have grown steadily.

Highlights from this CHPR research program during the 2021-2022 fiscal year appear below.

As part of the California Health Benefits Review Program (CHBRP), a UC-wide collaboration,
CHPR faculty and staff provided evidence-based analyses of nine bills for the California State
Legislature during FY 2021-2022 (Bill author): AB 1859 Mental Health Services (Levine); AB 1930
Medi-Cal: Comprehensive Perinatal Services (Arambula); AB 2024 Breast Imaging (Friedman); AB
2029 Health Care Coverage: Treatment for Infertility (Wicks); AB 2516 Health Care Coverage:
Human Papillomavirus (Aguiar-Curry); SB 974 Breast Imaging (Portantino); SB 1337 Coordinated

Specialty Care for First-Episode Psychosis (McGuire); SB 1338 Community Assistance, Recovery, and Empowerment (CARE) Court Program (Umberg and Eggman); and SB 1473 COVID-19 Therapeutics (Pan).

- CHPR staff, led by Dominique Ritley, CHPR senior health policy analyst, provided support for the multiday Pandemic Preparedness Workshop co-hosted by Healthy Davis Together and the Office of Grand Challenges in April 2022. Building on the powerful role universities like UC Davis played in the U.S. response to the COVID-19 pandemic, the workshop sessions illustrated the benefits of incorporating universities into disaster preparedness planning. Workshop results are serving as a foundation for further development of university-specific preparedness and response plans by the newly established Institute for Pandemic Intelligence. CHPR plans to continue supporting the Institute's efforts to influence and inform policies relating to preventing and managing future pandemics.
- Results of a study conducted by CHPR afffiliates Shani Buggs and Patricia Powers were published
 as a brief titled "Key Findings from Public Deliberation with Community Members about Police
 Reforms." The brief includes results of participant discussions of and preferences among four
 presented policy options for police reforms.
- CHPR's Associate Director, Dr. Jeffrey Hoch, and several other CHPR faculty affiliates have been involved in mentoring Sonia Singh as she completed her doctoral research. One paper from that research, "Cost-Effectieness of Patient Observation on Cranial CT Use with Minor Head Trauma," was published in Archives of Diseases in Childhood this fiscal year. Singh and her coauthors assembled an analytic cohort of 18,471 children presenting to the Emergency Department (ED) with blunt head trauma and stratified them by the Pediatric Rmergency Care Applied Research network (PECARN) traumaatic brain injury (TBI) risk categories. Their results indicated that planned ED observation inn selected children with minor head trauma was cost-effective for reducing CT use for the PECARN intermediate-risk and high-risk categories.
- UC Davis Health announced in October of 2021 that it is partnering with AKT Development Corporation (AKT) to develop a future "Community for Health and Independence" near its planned Folsom Ranch medical campus. CHPR's white paper (published June 2021), which explored how the two partners might leverage their respective experience and expertise to create a planned community focused on healthy aging in place for all its residents, including vulnerable and developmentally disabled adults, informed this public-private partnership. The CHPR report includes a description of regional demographics, existing resources for older and vulnerable adults, examples of model communities, and an overview of research on the use of technology, the built environment, and community-based interventions to facilitate aging in place. It also describes opportunities and challenges associated with UC Davis maintaining a relationship with the future "Community for Health and Independence" that include conducting community-based research and education to eliminate current gaps in knowledge about the interplay between social, physical, and environmental factors that influence healthy aging.

Healthcare Quality and Safety Research

Healthcare quality and safety research is critical to improving effective and efficient delivery of healthcare services in the United States. Patrick Romano, MD, MPH, a nationally renowned healthcare quality expert, has led the CHPR effort in quality and safety research for more than 15 years.

Highlights over this reporting period for this CHPR research program follow.

- A website launched in early 2022, Cal Long Term Care Compare (CLTCC), gives California consumers useful information to use in comparing the quality of various nursing homes. CLTCC centralizes publicly available information from federal and state agencies about nursing homes in California, offering metrics covering staffing, quality of facilities, fines and other quality-related information. Data analysis for CLTCC is led by CHPR affiliates and staff. The project's Co-Pls are Deb Bakerjian, a CHPR faculty affiliate and clinical professor at the Betty Irene Moore School of Nursing at UC Davis Health, and Patrick Romano, professor of internal medicine and pediatrics at UC Davis Health who also serves on CHPR's leadership team. The website's data and ratings will be updated on a bi-annual basis. While consumers are the target audience, CLTCC also will be useful to other stakeholders including nursing home providers, hospitals referring patients, policymakers, regulators, health plans and nonprofit organizations.
- Drs. Patrick Romano and Deb Bakerjian continued to serve as Co-editors in Chief for PSNet (Patient Safety Network), the web-based resource for evidence on improving patient safety supported by the Agency for Healthcare Research and Quality (AHRQ). In addition to curating a weekly newsletter featuring 20-25 recently published studies, tools, news articles and upcoming events, they and their UC Davis/CHPR editorial team published 21 expert commentaries on cases describing medical errors and patient harms from hospitals across the U.S. (WebM&Ms) in fiscal year 2021-2022, seven of which also provide continuing education (CE) credit for health professionals; they also published seven Patient Safety Primers, including "Strategies and Approaches for Investigating Patient Safety Events," "Debriefing for Clinical Learning," and "Deprescribing as a Patient Safety Strategy," as well as highlighting fourteen Emerging Innovations, representing unique approaches to patient safety improvement recently published in the peer-reviewed literature.
- CHPR-affiliated researchers conducted a study in which new parents with newborns in the Neonatal Intensive Care Unit (NICU) used videoconferencing technology to watch their babies while pumping or expressing milk. The study found parents who used FamilyLink, a videoconferencing technology, to watch their babies in the NICU reported an improved experience relative to parents who did not use the technology when they pumped breast milk. FamilyLink is available to parents at all times through a secure connection on their computer or mobile device. CHPR-affiliated researchers Drs. Laura Kair, James Marcin and Jennifer Rosenthal coauthored the study, published in Breastfeeding Medicine, with UC Davis Health colleagues Drs. lesha Miller, Kara Kuhn-Riordon, Caroline Chantry, and Kristin Hoffman. Dr. Adrienne Hoyt-Austin, assistant professor of clinical pediatrics at UC Davis Health and a former post-doctoral scholar with the CHPR Qualify, Safety, and Comparative Effectiveness Research Training in Primary Care (QSCERT-PC) Program, was the study's lead author.

Mental Health and Substance Use Research

Substance use disorders (SUD) and mental health issues take an enormous toll on our society through premature death, poor health outcomes, increased disparities, and unnecessary costs. CHPR researchers have made a substantial impact in these fields through their work on mental health, tobacco cessation, prescription opioid overuse, and the impacts of prescription opioid tapering on patient health outcomes. Highlights during this reporting period for this research program are given below.

Opioid Use/Addiction: For nearly a decade, more than a dozen CHPR faculty and fellows have been producing impactful research related to treating opioid addiction. Examples of the research conducted through CHPR on this important topic during FY 2021-2022 are given below.

- CHPR affiliate Dr. Alicia Agnoli, assistant professor of family and community medicine at UC Davis School of Medicine, was honored with a 2022 Top Ten Clinical Research Achievement Award by the Clinical Research Forum. This award is in recognition of her work studying opioid dose tapering which resulted in a paper titled "Association of Dose Tapering with Overdose or Mental Health Crisis Among Patients Prescribed Long-Term Opioids," published in JAMA this year, on which she is first author. Her coauthors on this important paper are Dr. Joshua Fenton, CHPR affiliate and professor and Vice Chair of Research in the Department of Family and Community Medicine, CHPR interim director Dr. Anthony Jerant, CHPR affiliates Drs. Daniel Tancredi and Elizabeth Magnan, and CHPR statistician Dr. Guibo Xing.
- Drs. Fenton and Agnoli and CHPR coauthors published another study examining potential long-term risks of opioid dose tapering this year. In that study they found that patients on stable but higher-dose opioid therapy who had their doses tapered by at least 15% had significantly higher rates of overdose and mental health crisis in the second year after tapering compared to their pre-tapering period. The study, "Long-term Risk of Overdose or Mental Health Crisis After Opioid Dose Tapering," was published in JAMA Open Network. CHPR researchers Elizabeth Magnan, Iraklis Erik Tseregounis, Guibo Xing, and Dan Tancredi were coauthors on this study.
- The CA Bridge program, a project of the Public Health Institute and co-founded by CHPR affiliate and professor of emergency medicine at UC Davis Health, Dr. Aimee Moulin, received an award from the California Department of Health Care Services this year to expand access to substance use and mental health services throughout the state by funding the placement of health navigators in California emergency departments. The new program, called CalBridge Behavioral Health Navigator Program (the Bridge Navigator Program) is another response to the fact that drug overdose deaths doubled from 2017-2021 in California and the Centers for Disease Control and Prevention (CDC) reported a record 107,000 overdose deaths across the U.S. in 2021.
- CHPR affiliate Dr. Stephen Henry collaborated with doctoral candidate Peter Torres from the UC
 Davis Department of Linguistics on a study designed to examine the language of pain, help
 doctors communicate better with their patients about it, and understand how doctors interpret
 opioid-related policies. CHPR facilitated the collaboration, which used video-recorded patientdoctor interactions collected by CHPR staff and audio records gathered with CHPR assistance.

Torres was honored with the Elizabeth Dayton Award from the Linguistic Society of America on January 8, 2022, in recognition of this research.

Tobacco Cessation: Elisa Tong, MD, MS, leads tobacco cessation research associated with CHPR. Her work, carried out with a 6-person team of CHPR staff, has led to changes in Medi-Cal tobacco policy and University of California and California Community College campus smoking policies that affect hundreds of thousands of students, staff, and faculty throughout the state. Changes to these policies influence young adult behavior and have significant, positive, life-long health (and cost) effects.

- Dr. Tong and the team are currently conducting two large tobacco cessation research projects
 at CHPR. The projects complement each other in their focus on multi-sector initiatives that
 implement and scale the integration of evidence-based treatments for tobacco dependence
 into safety-net clinics and hospitals to encourage tobacco cessation and mitigate health
 disparities.
- Research led by Dr. Tong, who is a professor of internal medicine, and published this fiscal year in the Journal of General Internal Medicine shows that some people may be overlooked for tobacco cessation counseling, putting them at risk for lung cancer. The study attributes the finding to the way healthcare providers are asking some people about their current tobacco use. The study, "Assessment and Counseling Gaps Among Former Smokers Eligible for Lung Cancer Screening in US Adults," found that if people are asked during lung cancer screenings "Do you now smoke cigarettes?" and they answer, "not at all," they might be classified as former smokers when, in actuality, they used tobacco recently.
- Dr. Tong also published a study examining the effectiveness of Tobacco Tracker, a tool to crowdsource reporting of tobacco use and related litter to shape behaviors linked to smoke-and tobacco-free policies and create healthier college campuses, in *Nicotine & Tobacco Research*. The study, "Tobacco Tracker: A New Tool to Support College Smoke and Tobacco Free Policies," surveyed students, faculty, and staff at two California public universities with 100% smoke- and tobacco-free policies, finding that awareness and use of Tobacco Tracker could mobilize campus communities to help reduce tobacco use.
- CHPR received a 5-year grant from the California Department of Public Health to provide intensive training and technical assistance on smoking cessation to some 40 community clinics serving at-risk populations. This smoking cessation program, named the Healthy Living Clinic Initiative (HLCI), is led by CHPR Associate Director Dr. Jeffrey Hoch, professor and Chief of the Division of Health Policy and Management in the UC Davis Department of Public Health Sciences; Dr. Desiree Backman, Chief of the Prevention Policy and Practice Group (3PG) at CHPR; and Dr. Neal Kohatsu, Chief Health Strategist of 3PG. The HLCI team will use a "whole health" approach to support patients who smoke in their efforts to quit by providing them with guidance on diet, physical activity, and stress management.
- CHPR and the UC Davis Comprehensive Cancer Center co-hosted Dr. Michael Fiore, the
 nation's leading expert on smoking cessation and evidence-based guidelines as part of CHPR's
 Seminar Series. Dr. Fiore leads the NCI-sponsored Cancer Center Cessation Initiative
 Coordinating Center at the University of Wisconsin where he is also the director of the Center for

Tobacco Research and Intervention. The seminar, "Unfinished Business: The Achievable Goal of Eliminating All Tobacco Product Use in the United States by 2030," was attended by more than 100 individuals in-person and via Zoom.

• CHPR affiliates Alicia Agnoli, assistant professor of family and community medicine, and Laura Kair, associate professor of clinical pediatrics, and their colleagues, conducted a study which found that the odds of starting and continuing breastfeeding is significantly lower among individuals who used a combination of tobacco and illicit substances during pregnancy. Adverse health outcomes for pregnant individuals and their children have been associated with prenatal tobacco and substance use as well as with suboptimal breastfeeding. Drs. Agnoli and Kair coauthored the study which was published in Breastfeeding Medicine this year and also coauthored by UC Davis' Kathleen Groh and additional colleagues Nichole Nidey, Christine Wilder, Tanya E. Froehlich and Stephanie Weber from University of Cincinnati.

Conclusion

CHPR continues to play a unique role in supporting and fostering interdisciplinary collaboration, among researchers and stakeholders within the University, and in other academic institutions, the community, and other private and public entities, toward solving some of our society's most significant healthcareand health policy-related problems. CHPR provides an important nexus for investigators with a broad range of expertise to collaborate on impactful research that informs healthcare delivery, quality, outcomes and costs.

Education Highlights

- In FY 2021-2022, CHPR participated in the training of multiple postdoctoral fellows as part of a federally funded T32 research training program: QSCERT-PC (Quality, Safety, and Comparative Effectiveness Research Training in Primary Care). (See Appendix 5 Table 1 for a list of all CHPR-affiliated postdoctoral fellows.) Susan Brown, PhD, and CHPR Associate Director Jeffrey Hoch both served as QSCERT-PC Program Directors. Fellows completing these programs have gone on to fill academic research positions or health policy leadership roles at UC Davis or at other research and policy institutions in the US.
- A range of topics in health services and outcomes research, as well as health policy topics, were presented during the CHPR Seminar Series (listed in the UC Davis General Catalog as EPI 291 and GMD 291, Seminars in Human Health Services Research & Clinical Epidemiology). The CHPR seminar series was converted to fully online in 2020 due to COVID-19 requirements, and in the process it has attracted a larger audience, including more people on the Davis campus. CHPR collaborated with the Comprehensive Cancer Center and the Clinical and Translational Science Center to co-host multiple seminars in Spring 2022. A list of seminar speakers and topics presented during FY 2021-2022 can be found in Appendix 5, Table 2, and on the CHPR website.
- CHPR co-hosted a joint research forum with the UC Davis Perinatal Origins of Disparities (POD) Center on May 25, 2022. The forum featured brief presentations and discussions among CHPR and POD researchers on a variety of topics of mutual interest.
- CHPR co-hosted a joint research forum with the UC Davis Center for Poverty and Inequality Research (CPIR) on October 29, 2021. This joint forum highlighted the work of faculty with overlapping research interests with the goal of sparking new collaborations, and was well attended.
- CHPR faculty continue to offer the popular, interdisciplinary course: Principles and Methods of
 Comparative Effectiveness Research (CLH: 210Y) coordinated by Dr. Jeffrey Hoch, the Instructor of
 Record (IOR) for this course. This traditionally hybrid course converted to fully online in the Spring
 quarter of 2020. The course introduces students to basic methods used in comparative effectiveness
 research and engages students in team science for final projects. In prior years, a number of
 students have gone on to publish their final projects after completing the course.
- CHPR faculty continue to mentor undergraduate students, graduate students, medical students, postdoctoral fellows and junior faculty in research on healthcare outcomes, quality, access and costs to inform best healthcare practices and health policy. For example, multiple CHPR affiliates, including Jeffrey Hoch, James Holmes, Nathan Kuppermann and Daniel Nishijima, mentored Sonia Singh as she completed her doctoral research and published "Cost-Effectiveness of Patient Observation on Cranial CT Use with Minor Head Trauma." See the "Personnnel" section of this report for lists of students and fellows mentored by CHPR-affiliated faculty.
- CHPR staff members Melissa Gosdin, PhD in sociology, and Bethney Bonilla, MS, continued to lead recurring meetings for CHPR affiliates and staff on anti-racism matters; they present materials on

various issues related to diversity, equity and inclusion and the group discusses them and ways to use what has been learned to inform CHPR hiring and other practices.

- Dr. Melissa Gosdin provided mentoring to graduate students (e.g., Ren Bruguera, UCD medical student and Rukhshanda Rehman, Department of Human Ecology), undergraduate students (e.g., Youth Community Scientist Academy mentor for Health Equity and Outreach [HERO] program with the CTSC), and junior faculty (e.g., Dr. Simon Ascher, Hospitalist Medicine and Dr. Sonia Singh, Emergency Medicine). She also contributed substantially to teaching serveral School of Medicine courses, including co-instructing with Dr. Karlin's In the course "The Qualitative Experience: I-RESTORE" and guest lecturing for Dr. Romano's "Qualitative Research Methods" course and Dr. Shaikh's "Enhancing Quality Improvement and Patient Safety" course.
- After consulting with staff from the UC Davis Diversity, Equity, and Inclusion office (DEI), CHPR
 established a schedule of unit-wide training sessions led by DEI staff and held on a bi-monthly basis.
 The first session, "Understanding Diversity and Social Justice," hosted by Eric Sanchez, Associate
 Director of the DEI Education Program, was held in June 2022.

Future Vision

Led by Interim Director Anthony Jerant, the first six months of FY 2022-23 continued to be a period of transition for CHPR while a competitive search was conducted to select a new permanent Director to lead the Center. A new and permanent Director is expected to be appointed in early 2023. The Center will continue to adapt to the ongoing COVID-19 pandemic. CHPR will be working in a hybrid-remote environment this year, while maintaining its high level of productivity and service, for its members, the University, and for the improvement of healthcare generally.

Key goals and initiatives for CHPR over the next year include:

- Foundational planning: Once a new and permanent Director is in place, CHPR will follow up on the various Center-related issues discussed during the foundation planning sessions held in FY 2021-2022. A retreat with CHPR leadership is envisioned as a means toward initiating this process. CHPR's leadership team worked with Kapur International, a well-regarded external consulting firm, to carry out this foundational work. A successful approach popularized by Simon Sinek is being employed in this work; through this approach, CHPR's purpose ("why" statement) was defined during FY 2021-2022 and CHPR's "how" and "what" statements will be created after a new Director is appointed in 2023.
- Continue to promote financial sustainability: CHPR is heavily dependent on extramural funding; therefore, despite consecutive years of financial growth, the Center continues to explore ways to diversify its funding sources.
 - As indirect cost recovery can factor into whether a grant or contract proposal is submitted through a PI's academic home department versus through CHPR, CHPR and its new Director will consider whether sharing of indirect cost recovery is an appropriate option for encouraging more PIs to use the Center's grant- and research-related services.
 - o CHPR will explore ways to utilize available funds from indirect costs to support and expand key initiatives of and services offered by the Center.
 - O CHPR will continue working with Development and Alumni Relations officers, on both the Davis and Health Sciences campuses, to pursue philanthropic avenues to promote the Center's financial sustainability. For example, CHPR will continue to participate in UC Davis Give Day and will utilize the services of personnel in UC Davis Foundation Engagement and Alumni Relations to identify opportunities to fund Team Science projects such as those being proposed by Drs. Stephen Henry and Aimee Moulin to help curb the current US opioid crisis.
 - CHPR will continue to submit grant and contract proposals that focus on health-related research and policy, with special emphasis on those that promote health equity among diverse populations.

- Increase visibility of CHPR as an Accelerator of Healthcare-related Innovation = Research:
 - O CHPR is working closely with Page Design, while also utilizing the latest TeamSite tools and updates, to explore efficient ways to redesign and improve the user-friendliness of CHPR's website. CHPR's new website went live at the end of December 2022 and will go through frequent updates throughout FY 2022-2023 to maximize its effectiveness.
 - Additionally, CHPR will expand upon a marketing plan initially implemented in Spring 2020, the goals of which are to improve engagement on its social media platforms (Facebook, Twitter, Instagram, and LinkedIn) and with the Center's website.
 - The Center will also put more emphasis and resources on disseminating CHPR research results and call more attention to the highly skilled and efficient teams of researchers including faculty and staff—affiliated with CHPR.
- Establish additional collaborations with faculty on the Davis campus: CHPR will continue to engage with faculty at the main Davis campus (e.g., Departments of Public Health Sciences, Sociology, Communication, Psychology, and Human Ecology), in addition to faculty in many departments in Sacramento at the School of Medicine.
 - CHPR will support the submission of an AHRQ T32 training grant through CHPR in the Fall
 of FY 2022-2023 with Co-Principal Investigators from the Davis campus (Dr. Leigh Anne
 Simmons, Human Ecology) and the Sacramento campus School of Medicine (Dr. Jim
 Marcin, Pediatrics).
 - CHPR plans to explore jointly hosting another research forum with the UC Davis Center for Poverty and Inequality Research (CPIR) or other research units located at the Davis campus. Such a joint forum with CPIR took place on October 29, 2021; it highlighted the work of faculty with overlapping research interests with the goal of sparking new collaborations, and was well attended.
 - CHPR will also consider engaging in additional collaborations with other departments or centers in issuing pilot grant awards.
- IAB and EAB meetings: CHPR will hold meetings of its Internal Advisory Board (IAB) and External Advisory Board (EAB) soon after a new Director is appointed and is ready to lead these activities.

- Expanding and diversifying CHPR funding sources
- Expanding computing capacity to enhance CHPR faculty affiliates' ability to compete for research support involving analysis of large health datasets
- Expanding capacity to provide policy analysis and other analytic services to UC Davis Health personnel
- Enhancement of communication/marketing to increase CHPR visibility
- Increasing funding from external donors for Center-specific initiatives and education
- Establishment of additional cross-departmental, multidisciplinary collaborations for training researchers
- Provision of support for faculty who are pursuing large (P-type NIH) grants that include research
 infrastructure (e.g., "cores"), as CHPR is doing for Drs. Stephen Henry and Aimee Moulin who received

Threats

- As a result of CHPR's move out of the Grange building, the on-campus ICR rate is now required for new grant proposals submitted through CHPR, which can affect whether PIs submit their grant and contract applications through the Center
- Potential departure of staff due to 100% remote work opportunities elsewhere that come with salary increases and/or promotional opportunities
- Potential decline in collaboration with SOM departments and decline in grant submissions due to altered incentives in the SOM Funds Flow model
- Potential declines in relevant funding opportunities and increased competition for existing funding opportunities
- Reduced extramural funding may lead to loss of support for research staff

Appendix 1: Strategic Plan

During FY 2021-2022, CHPR completed the following strategic planning tasks:

- 1) During this fiscal year, the 15-year review of CHPR as a UC Organized Research Unit (ORU) was completed and the Center was renewed as an ORU for 5 more years. The Review Committee was very supportive of CHPR continuing as an ORU and provided a number of recommendations, such as planning for space at Aggie Square, recruitment of a strong Director, and encouraging CHPR to develop additional collaborations with schools and colleges on the main (Davis) campus.
- 2) While not originally planned to take place during FY 2021-2022, CHPR relocated from the Grange location to the Broadway building after UCD Health advised CHPR leadership of the lease of the Grange building ending at the end of FY 2020-2021. (Previous to FY 2020-2021, CHPR and UCD Health leadership had explored whether the space at the Grange building should be brought up to seismic code or whether it would be more beneficial over the long-term for CHPR to move out of that leased space altogether.) Conducting the move required much coordination with numerous UCD Health, School of Medicine, and various campus departments, took place during the COVID-19 pandemic with limited availability of staff resources from these other units, and required joint investment from CHPR, the Office of Research, and the School of Medicine Dean's Office for new furniture, new lighting, fresh paint, new carpet, and new computing equipment.
- 3) Dr. Anthony Jerant, M.D., Professor and Chair, Department of Family and Community Medicine, became the Interim Director of CHPR effective July 1, 2021. Dr. Jerant took over for Dr. Joy Melnikow, who retired after 12 years of leading the Center; as an emeritus faculty member, Dr. Melnikow continues to support research projects and other activities at CHPR.
- 4) CHPR continued to brainstorm and seek ways to improve its visibility and branding during FY 2021-2022 and, in keeping with a recommendation from the review committee of the Center's 15-year ORU review, CHPR hired a new Digital Communications Specialist in January 2022.

Notable Outreach Activities

- In partnership with the California Health Benefits Review Program, CHPR faculty and staff
 members contributed non-partisan, evidence-based analyses of effectiveness, public health
 impacts, and cost and utilization of proposed health insurance legislation to inform state
 lawmaker decisions. Nine bills were analyzed in a 60-day time period, meeting the state
 legislature's policy committee timeline.
- The CHPR Seminar Series (see Appendix 5 Table 2) continued to be held virtually and with great success. Presentations were also posted online in order to be available for later viewing.

Appendix 5: Additional Information

Foundational Planning

As mentioned in the Future Vision section, CHPR collaborated with Raj Kapur, external consultant with the Center for Project Management, to work on foundational planning as the Center prepares for an eventual new and permanent Director to be appointed in 2023. Much of the focus of this work was on CHPR's "What" (e.g., CHPR's services), "How" (i.e., strategy), and "Why" (e.g., role and contributions CHPR makes).

Several dedicated stakeholder interviews took place with key Center affiliates and Center managers to seek what input on matters such as what is working well and needs improvement. On November 29, 2021, the Center hosted a "Charting our Future" event with affiliates and staff to discuss much about the foundational planning work and to jointly create a final "Why" statement.

Awards and Recognition

- CHPR affiliate Dr. Alicia Agnoli, assistant professor of family and community medicine at UC Davis School of Medicine, was honored with a 2022 Top Ten Clinical Research Achievement Award by the Clinical Research Forum. This award is in recognition of her work studying opioid dose tapering which resulted in a paper titled "Association of Dose Tapering with Overdose or Mental Health Crisis Among Patients Prescribed Long-Term Opioids," published in JAMA this year, on which she is first author.
- CHPR affiliate Dr. Sergio Aguilar-Gaxiola was appointed by Gov. Gavin Newsom to join other California leaders to promote health and wellness across the state. Dr. Aguilar-Gaxiola is the founder and director of the UC Davis Center for Reducing Health Disparities and a professor in the Department of Internal Medicine at UC Davis Health. The Governor's Advisory Council on Physical Fitness and Mental Well-Being is led by First Partner Jennifer Siebel Newsom and Pro Football Hall of Fame inductee Ronnie Lott, and comprises leaders from health and wellness organizations, youth sports programs, education, the entertainment and fitness industry, and other experts on physical and mental health.
- CHPR affiliate and UC Davis Health Department of Surgery Distinguished Professor and Chair
 Diana Farmer received a 2022 Harrington Scholar-Innovator Award or her spina bifida work,
 given by the Harrington Discovery Institute at University Hospitals of Cleveland, Ohio. The award
 included a grant to support further development of Farmer's "patch" technology, used currently
 during surgeries to treat spina bifida in utero, for use in treating adult-acquired cord injury.

Appendix 8: Diversity, Equity & Inclusion

- CHPR continued its Center-wide DEI initiative of providing a space dedicated to learning about, discussing, and acting upon anti-racism. Led by Melissa Gosdin, PhD, and Bethney Bonilla, MA, the anti-racism group continues to meet monthly and is open to all CHPR staff and affiliated faculty.
- After consulting with staff from the UC Davis Diversity, Equity, and Inclusion office (DEI), CHPR
 established a schedule of unit-wide training sessions to be led by DEI staff. The first session,
 "Understanding Diversity and Social Justice," hosted by Eric Sanchez, Associate Director of the
 DEI Education Program, was held in June 2022. [See also the Education Highlights section]
- Associate Director Hoch and colleagues published "How Economic Decision Modeling Can Facilitate Health Equity" in the AMA Journal of Ethics. The article offers examples of how economic modeling, through its design and use, can motivate inquiry and research into health equity. Using examples from some of CHPR's recent research projects, the authors describe how modeling can be used to study reduction of health inequity, and thereby motivate different types of investments into rectifying such inequities. The article also considers how equity fits into cost-effectiveness frameworks and how economic modeling can broaden the range of options for improving health equity, among other considerations. Logan Trenaman, Ph.D., who was a postdoctoral fellow with CHPR when this work was carried out, Shannon Hearney, M.P.H., a Ph.D. student in the Graduate Group in Public Health Sciences (GGPHS), and Carolyn Dewa, Ph.D., M.P.H., a professor in PHS and the UC Davis Department of Psychiatry and Behavioral Sciences, co-authored this paper with Professor Hoch.
- Dr. Gosdin continues to mentor graduate and undergraduate students of underrepresented groups, for example, Ren Bruguera, a graduate student in Public Health Sciences, on ongoing qualitative projects.
- Dr. Gosdin worked served as a Youth Community Scientist Academy mentor for the Health Equity Resources and Outreach (<u>HERO</u>) Program, UC Davis CTSC. This is a program designed to introduce underpriviledged high school students to research methods and careers in health research.
- CHPR faculty affiliate and medical director of Express Care at UC Davis Health, Joshua Elder, was awarded funding for UC Davis Health's Digital Health Equity Program to help establish a regional digital public health platform in the Sacramento area and northern California region. Along with support from 16 regional stakeholders, Elder seeks to improve access to and continuity of care for vulnerable populations through this project. The project expands UC Davis Health's ability to partner and coordinate with federally qualified health centers to provide more services and simplify access to health care.

- The <u>Cal Long Term Care Compare website</u>, an effort to help drive transparency, accountability, and improvement in long-term care for all Californians and for which the CHPR Healthcare Quality and Safety Research team received an award from <u>Cal Hospital Compare</u> to report on nursing home quality metrics in California, was launched.
